2.) Junior horses must complete 2 NJTRA rides of any length.

Certificates in the amount of \$100 each and redeemable toward a ride entry will be awarded to the highest point placing Open Division Rider, Driver, and Junior.

Certificates in the amount of \$50 each and redeemable toward a ride entry will be awarded to the second place Open Division Rider.
